

State Lieutenant Governors Recycling Impact Award

ISRI will present the Recycling Impact Award at the National Lieutenant Governors Association* (NLGA) Annual Meeting, July 17-19, 2019 in Wilmington, DE. The Recycling Impact Award will be presented to a member of the NLGA who is committed to working within a state, region, and/or communities to positively impact resource conservation and recycling.

AWARD CRITERIA

To be eligible for the award, the state policymaker must be:

- An NLGA member (i.e. all state LG's / second-in-command)
- Recognized for supporting recycling industry initiatives.
- An advocate for policy benefiting the recycling industry.
- Engaged with the industry (site tours, attendance at ISRI events, etc.), or identified by ISRI members for future engagement.
- Accessible and responsive to recycling industry concerns.
- Present at the NLGA Annual Meeting to receive the award.
- An individual who has not been disqualified by past work against industry initiatives (particularly DSW / Scrap is Not Waste)

NOMINATION PROCESS

Nominations are being accepted now through May 15, 2019.

- ISRI Chapters and members are asked to submit nominations for the Recycling Impact Award at www.isri.org/ltgovaward
- NLGA staff and NLGA corporate members may also submit nominations through NLGA.org.

SELECTION PROCESS

An ISRI-designated three person selection committee will be formed to rank the nominees and select a winner from the pool of eligible candidates.

- To keep the selection process fair, the committee will be comprised of ISRI members from states that do not have a nominee for the award.
- In the event there are multiple eligible candidates with similar rankings, the ISRI Chapter Presidents may be consulted for further insight on the nominees' qualifications.

AWARD PRESENTATION

The NLGA Recycling Impact Award will be presented annually at the NLGA July Meeting by interested ISRI Members who ideally are from the award winner's state and by representatives of the ISRI Chapter in which the annual NLGA meeting is hosted. Contact ISRI Staff if interested.

*The National Lieutenant Governors Association (NLGA) is the professional association for the elected officials first in line of succession to the state governors in the 50 states and five U.S. territories. The purpose of NLGA is to promote efficiency and effectiveness of the office of lieutenant governor, to foster interstate cooperation, to provide a medium for the exchange of views and experiences on subjects important to the people of the states and territories. Each state's constitution dictates who is first in line of gubernatorial succession should a vacancy occur. This official is the NLGA member. ISRI is a Chairman's Partner with NLGA for the purposes of promoting the recycling industry and educating state policymakers on the economic and environmental benefits of recycling.
